Financial Information

Tuition is spread evenly over ten months from August to May. The entrance fee is paid up front. August statements will be mailed to parents when the list of enrolled students is provided to the Treasurer. Tuition payments are due on the first of each month.

Full-Time Tuition and Fees for the 2023-2024 School Year

Full-time is defined as attending 50% or more of the school week.

Part-Time Tuition and Fees for the 2023-2024 School Year

Part-time is defined as attending less than or up to 50% of the school week.

Constituent and supporting churches provide a large fraction of the school's operating cost. Therefore, students associated with these churches receive a tuition discount. Students who are a baptized member of a constituent or contributing church or are living with a parent or legal guardian who is a baptized member of a constituent or contributing church, are eligible for these discounts.

New Students Discounts

The following guidelines are designed to encourage families to send students to the Tri-City Seventh-day Adventist School. (The program includes families with or without a Seventh-day Adventist background.)

1. Students from a family whose children have not previously attended any Seventh-day Adventist school (either full or part-time) are eligible for a 25%

- tuition discount for each student, during the year when their first student attends Tri-City Seventh-day Adventist School.
- Students from a family that attended Tri-City Seventh-day Adventist School during the school year following the first year of participation in the incentive program are eligible for a 15% tuition discount. The second year for eligibility must immediately follow the first year of the family's participation in the incentive program.
- The Tri-City SDA School Board is authorized to approve eligibility for the incentive program under special circumstances or situations not specifically covered by the above guidelines.

All applicable discounts (including any specific church discounts, multiple students' discounts, and the new to Adventist education discounts) will also be applied to part-time student charges.

Payment in Advance

A full or half year's tuition paid in advance will be discounted 2%.

Nonpayment of Tuition

When a student's tuition balance exceeds the equivalent of two month's tuition, a student will not be able to attend beginning the day after the statement due date unless suitable arrangements have been made with the school board. The school will also notify the pastor of the church involved.

Any student account that is in arrears when school starts must pay one month's tuition before the student can enroll, and then continue to pay each month in advance for the student to remain in school. (Payments are due by the first day of each month.) Advance payments are required for the student to continue to attend, until the account balance is paid in full.
